## In case you missed it, here's what happened: A Recap of the 2015 TBI Annual Meeting

Members of Temple B'nai Israel gathered on June 10<sup>th</sup> for our Annual Congregational Meeting. A lively crowd heard President Alvin Gingold summarize the year's events including the successful Shabbat dinners, lay-led services on the 4th Friday of each month, Annual Congregational Picnic at the end of the school year, Community Seder and more.

Mike Starkman, Treasurer delivered a positive review of the Temple's financial health, noting that this is the first year in a long while that we are essentially breaking even - with only a projected deficit of \$350. He reviewed the proposed budget for the coming fiscal year, which starts July 1, asking the congregation to approve it, which they happily did in a unanimous vote.

Stephen Sickerman, representing the efforts of By-Laws Review Committee members Barbara Shykoff and Alvin Gingold, presented needed revisions in our Temple By-laws. The two biggest changes are the discontinuation of the semi-annual congregational meeting in January, leaving only the June Annual Meeting, and the reduction of the number of Board members from nine to seven. Both changes reflect a more realistic view of how we operate. The congregation voted to accept the by-laws as revised by a unanimous vote.

The Annual Meeting is the setting in which our Volunteer of the Year is honored. This year that honor goes to Daniel Sternlicht. Daniel has served our congregation in many ways including lending his beautiful voice and considerable musical abilities to High Holiday services, teaching Jewish songs and prayers to our religious school students and serving as a trustee on the TBI Board. Congratulations to Daniel!

Alvin Gingold gave a brief report outlining ritual activities over the past year including the Chanukah party, Purim celebration, Tu B'Shevat mini-Seder, Passover Seder, Shabbat dinners with Rabbi Baroff, fourth Friday lay-led services, Havdalah on the Beach and more. Leah Apothaker, our Fellow with the Goldring/Woldenberg Institute of Southern Jewish Life (ISJL), was in Panama City three times conducting services and working with the religious school children. Alvin and his wife Cynthia will be attending the annual ISJL Education Conference in Jackson, MS in late June to prepare for the 2015-2016 religious school year. Alvin also noted that we have not yet secured a rabbi for the coming High Holidays as Rabbi Rutberg, our HHD Rabbi the past three seasons, has accepted his own pulpit. Alvin has enlisted the help of national organizations to locate an available rabbi, and is confident that we will be able to do so.

Cynthia Gingold reported that the religious school has grown from five students to eleven! They have been actively learning the Hebrew alphabet, Jewish songs, prayers and traditions as well as participating in the celebration of Jewish holidays.

Lisa Rahn spoke briefly about the successes of the Sisterhood

including fundraising efforts and community involvement. The Sisterhood is welcoming new members and invites anyone interested to join for a mere \$36 per year.

Nathan Miller introduced the idea of acquiring a new ark for the synagogue. Nathan, Ed Nagler and Lori Zipes have started researching costs and vendors. Many attendees expressed their opinions about such an endeavor and it seems there is interest. But should we purchase an ark? Should we design and build an ark ourselves? What requirements exist, if any, to build an ark? How much will it cost? What style should it be? These are only some of the important questions that need to be explored. Nathan would like to start raising funds for this project as soon as possible, so Sarah recommended that a committee made up of Nathan, Lori, Ed and Mike Starkman be formed to investigate the possibilities. The Board will add this item to the next meeting agenda as well.

One last objective of the Annual Congregational Meeting remained: Election of officers and board members for the new term. The congregation unanimously approved the new slate, as described on page 1 of this issue. Congratulations to all!

Alvin thanked the outgoing Board members – Stephen, Pam and Daniel – for their service. Joan Prows led the attendees in applauding Alvin for his leadership over the past two years. And, with that, the 2015 Annual TBI Meeting was adjourned.

#### The Gavel Passes

Alvin Gingold has served Temple B'nai Israel as its president for the last two years. During his term he has focused his energies on creating more spiritual and communal opportunities for members. Alvin was instrumental in developing and maintaining the Friday night Shabbat dinners when Rabbi Baroff is in Panama City. These dinners have grown to be quite popular and tasty. They serve to bring congregants together to welcome Shabbat and

learn more about each other and the Rabbi.

In addition, Alvin has spearheaded the effort to add lay-led services on the fourth Friday of each month, extending the spiritual reach of the temple. Most congregants have volunteered to lead a service during the year, offering a diverse approach to welcoming the Sabbath.

During his tenure, Alvin has seen

new families join the temple community, increasing the number of students in the religious school. He has served on the Ritual Committee, tutored many b'nai mitzvah students, and fried countless latkes.

The community extends a heartfelt thank you to Alvin for his hard work and commitment to ensuring a Jewish presence in Panama City. Alvin will remain on the Board filling the role of Secretary.
